

Contest Rules Facebook contest Culture Market X THE PIROUETTES by the ADAM - Brussels Design Museum (23 August to 27 August 2018)

This contest is in no way sponsored, supported or managed by Facebook, nor is it affiliated with the Facebook organization. By participating in this competition, the participant irrevocably waives all claims towards Facebook.
2. The information provided by the participants is intended for the ADAM - Brussels Design Museum, and not for Facebook.
3. Participation in this competition is free.
4. By participating in the Facebook contest, participants agree to the terms of these regulations.
5. Participants under the age of 18 must have permission from their legal representative.
6. Employees of the ADAM - Brussels Design Museum are not excluded from participation but do not stand a chance of winning the prize package.
7. Each personal profile (social media) can only participate once per game. If several participations are determined, the first entry is considered to be participation.
8. Company pages, groups or profiles that do not comply with the rules of the social media channel are excluded.
9. ADAM - Brussels Design Museum reserves the right to disqualify a participant in the Facebook competition and / or exclude participation if this participant acts in any way in violation of these regulations or otherwise acts unlawfully towards ADAM - Brussels Design Museum .
10. Participants must live in Belgium.
11. The winners will receive a prize as communicated on the Facebook competition page, in particular 1 x 2 tickets for exclusive showcase on 31st of August of The Pirouettes, in honor of the Culture Market.
12. The winning prizes of the competition will be mentioned on the Facebook page of the ADAM - Brussels Design Museum. The prize winner is chosen on the basis of 2 criteria: tagging a friend and the degree of originality in the description of a song by The Pirouettes using a maximum of 5 emojis. Afterwards, a panel decides on the five most original comments and awards the prizes to the winners. No debat is possible against the result of the jury.
